The cold weather didn't stop her from finding fun activities to do during the winter months. Ambre's school experience was very different from her school life in France. She gave reference to the experience of dissecting a cat and do a rocket project along with fighting a bull and singing in the choir. Ambre helped with the "yearbook publications", also.
